Bert called this meeting to order by reading the Smart Start.

Command Center – There are two command centers. Both the stationary and the mobile command center will have complete communications capability for voice and data (i.e., satellite dish, portable satellite phones, walkie talkies – Nextel works great). Louis Todd to coordinate. The mobile command center (extended cab pickup truck) will move throughout the affected area and must always have complete communication capability through a portable satellite dish. The stationary command center will reside at a Waffle House location (parking lot). It will be an RV suitable for sleeping four

- Need a phone list of all local vendors by market. Monty Baldwin will provide.

- Need one full-time PR person Pat Warner will be that person.
- Need to get signs distributed early.
 - Car (emergency response vehicle)
 - "Now Hiring" signs for units opened
 - 1-800-"Now Open" Associate call instructions posted in unit before closing so they see it if unit is closed when they get back
- This year, we should do a better job of:
 - Knowing where OPS people (management/hourlies) went
 - Dumpster pickup
 - Port-a-potties (Louis Todd will handle)
 - Cash receipt tracking (track any money given out/spent)
 - Beverage distribution (Louis Todd will handle)
 - First wave Need someone to lock down motels (2 people); should have a dedicated motel room reserver
 - Fuel quicker Todd Lee has a friend who is a fuel distributor just need a truck to put the fuel
 in
 - Broadcast the 1-800-# to people affected (Pat Warner will handle)
 - To-go menu pricing (Greg Rollings)
 - Put all money in bank change fund
 - Put all food in freezer and turn to 0°
 - Food distribution (Louis Todd and Monty Baldwin will handle)
 - Need ice, water, soft drinks (cans), to-go supplies, bread, dairy, produce, wipes for table, i.e., bare necessities, for units that open first.

Control

- Bank all money
- Standardize food drop shipment
- Hold Coach's Clinics/Town Hall meetings on pre-hurricane season (one for each Area) to calm and reassure hourly associates by June 30th – Pat Warner and Rickey Crawford to work with Barbara Hammac, Rob Abney, Craig Golden, and Rusty Whaley. Let Bert see proposal.

- RV's for operators They need a place to stay. Don't depend on motel rooms. Monty Baldwin is in charge of RV rental. (Operators buy/bring their own sheets/pillow cases/towels) Pillows?
- Daily Construction/OPS/CIC debriefing is necessary.
- Daily operations meeting at end of day is necessary.
- Need plenty of "Open Now Cash Only" signs. Pat Warner will handle. Also, "Now Hiring" signs.
- Incoming team should overlap with outgoing team for about a half a day to debrief and catch up.
- To contact Corporate Office, use CIC. Rickey Crawford will publish rules.
- Keep good receipts for insurance purposes

Order of Battle - OPS

1. As storm moves north, OPS approaches in a pincer movement from east and west under storm. If Atlantic, approach from west under storm

Operations

- 2. Assess power issues
- 3. Decide on opening order:
 - Now
 - 2-3 days
 - Later than 3 days (4 days 2 weeks)
 - Damage/water cannot open
- 4. Move food from "longer to open" units to "open ASAP" units
- 5. Place small generators on walk-in freezers as necessary to keep food cold
- 6. Attach generators.
- 7. Organize and open units.
- 8. Re-supply.

Purchasing

- 1. Send first wave automatic order of ice, water, canned cokes, to-go supplies to CIC location.
- 2. Take orders/ship product.

People & P/R

- 1. Locate motel rooms and secure with credit cards (30 days blocks of 5-10 rooms per motel).

- Bert started the meeting with two handouts (attached) (1) Hurricane Prep Meeting Notes from last year, and (2) Note from Rob Abney about the Gulf Coast Hurricane Katrina Update.
- Command Center There will be two command centers. One will be a stationary command center which is an RV that can sleep from four to six people and has a generator and satellite communications system. The other is a 4x4 pickup truck which has handheld satellite communications equipment and an 80-gallon gas tank in addition to the regular tank.
- Pool of Trained Commanders in Chief (CIC's):
 - Steve Wright
 - o Rob Abney
 - Ray Daniels
 - o Bill Frazier
 - o Jim Hosseini
 - Craig Golden
 - Rusty Whaley
- We have three portable satellite telephones; they have all been tested. One will be used in the truck, one will be used for RV back-up, and one will be used in the roaming vehicle (Jim Horne).
- Construction will need a large lot to set up their command center (Jim Horne).
- Common keys for locks on the Gulf Coast Rob Abney and his team are working on getting the last ones keyed this week. Locks for the Atlantic side – Rusty and his Division Managers

have a set of keys to all units. Todd Lee doesn't have a set; Rusty will send a clearly marked set. Jim Hosseini will send Todd a clearly marked set for his units on the Atlantic side.

- Monty Baldwin will update the phone list for all local vendors and copy Bert and Patty.
- Jeff Cole will update the maps and copy Bert and Patty.
- We will build a file of "take alongs" for the first wave in the event of a hurricane. It will include:
 - Vendor phone lists (Monty)
 - Extra set of keys
 - Emergency menus
 - Associate call-in instructions
 - Key fobs for separate markets
- Our on-site PR person will be Pat Warner.
- Emergency signs
 - o Pat Warner has magnetic signs and windshield signs for emergency vehicles.
 - 1-800-"Now Open" signs with instructions for associates Pat has these signs, also.
- Things We Should Have Better Control of:
 - Know where management people go to flee the storm. It's best if they go east or west, not north.
 - Dumpster pickup Walt Taylor is the man in charge. All calls will come through Rickey Crawford first, and Rickey will alert Walt of pickup needs. The rule is use everybody else's dumpster first – they're not open!
 - Louis Todd will handle port-a-potties.
 - o Louis Todd will handle beverage distribution through US Food trucks.
 - Cash receipt tracking Control Department (Craig Knight/John Bridges) will handle/manage this. The rule is bank all money before the storm hits.
 - In the first wave, need two people to lock down hotels Will Mizell + one other person.
 - Fuel quicker Todd Lee and Jim Horne have local suppliers and have bought six tanks which hold 500 gallons of fuel each. They can hold regular gas or diesel fuel.
 - Rusty Whaley and Paxton Green need to start "shaking hands" and getting to know some fuel contacts in their markets.
 - Generators We have two 80KW generators sitting in the LES parking lot on standby. Can be pulled by a truck with a trailer. We need to "test fire" them, now.
 - Additional generators can be obtained on a first come/first serve basis. Walt Taylor is the POC FOR ADDITIONAL GENERATORS.
 - We also have six 7KW generators that will run freezers and a couple of lights.
 These generators are stored at LES and be transported with a pickup truck.
 - o Greg Rollings is working on to-go menu pricing. Turkey was added to the menu per the operators' approval.

Control

- 1. Bank all money in the unit when the restaurant closes.
- 2. Do Coach's Clinics on pre-hurricane season again this year. Pass out key fobs at that time.
- 3. Standardize food drop shipment.
- 4. Craig and John to provide Bert with a plan for better accountability of larger (costlier) food items when moving between units.

Jim Horne

- 1. Support team as follows:
 - a. P.M.
 - i. Fuel supervisor
 - ii. Someone in charge of generators
 - iii. Electrician
 - iv. Support team (fuel/transportation) 3-4 superintendents

LES

1. LES will provide miscellaneous motors/parts/fans for Construction to take with them. Ben Aune will create a plan for parts accountability. Give Bert a copy of the plan. Also give Bert a list of the items (critical parts and commonly needed items) to be sent down with the Construction team.

Purchasing

- 1. Monty Baldwin is in charge of this. The standard order, i.e., ice, water, canned drinks, is enough for four units. The first truck doesn't have food. After that, inventory as units open and call Rickey in the Command Center.
- 2. Louis Todd will send the plan to the senior operators to look at for comments/revisions.
- 3. Closed units are filled with bread.

Order of Battle

- 1. Assemble hurricane prep group for meeting when hurricane is eminent.
- 2. Tell Operations what to pack, where to go, and when to leave
- 3. Stage generators.
- 4. As storm moves inland, ground forces travel in around/behind it. Air support arrives when able
- 5. Inspect units/decide on priorities/CIC location.
- 6. Set up command centers and go to work.

Miscellaneous

- 1. Monty Baldwin is POC for RV's.
- 2. Monty Baldwin is in charge of food.
- 3. Food orders go directly to Monty Baldwin.
- 4. Rickey Crawford is in charge of rental cars.
- 5. Everyone goes through Rickey Crawford at Command Center, i.e., what's open, what's closed, what to put on the phone list.
- 6. Rickey Crawford is in charge of next day air items.
- 7. Jim Horne is in charge of gas.
- 8. Todd Lee is in charge of construction.
- 9. The SVP in each market will be in charge of the market, i.e., Rob Abney, Rusty Whaley, etc. The CIC coordinates and runs the overall show.
- 10. Patty Vanover will update POC hurricane cards to use in all markets. Get the satellite phone numbers and put on the cards, as well.
- 11. Have an end of day meeting every day.

JWR

- 1. Need to have a pre-hurricane drill. Who's driving the RV? Who's driving the pickup truck? What's our back-up plan? (Drill with drivers and backup + ATL Team 5 operators set for 2:00 p.m. on June 11, 2007, or come in if weather dictates.)
- 2. Outline RV/pick-up truck protocol line-up as well as what to pack, operating list for people/supplies. Louis Todd has the lead.

- 3. When it's real (hurricane brewing in the ocean), do a drill. People pay attention when it's real.
- 4. Talk to Home Depot, Cingular, Wal-Mart, Lowe's, and meet with their emergency planner. If these companies, along with Waffle House, are willing to share the expense, it may be more doable and cost effective to install a cell tower for better communication. Louis Todd will make preliminary contact with them to possibly partner with them.
